One bid was received and opened April 24, 2025, for the above referenced project. The project was advertised in The Spectrum on March 23 and 30, 2025, and on the Quest CDN bid website. Woolpert also distributed the bid advertisement to contractors who had previously bid or worked on past airport projects. In total, three prime contractors, one subcontractor, two suppliers, and two plan rooms requested plans from the bid site. See attached plan holder list. One prime contractor attended the pre-bid meeting and site visit.

The bid was reviewed for mathematical accuracy and is summarized in the attached Bid Summary and Tabulation. There were no mathematical errors identified.

Our office has reviewed the bid proposal submitted by Mesquite Electric, LLC, for compliance with the Instructions to Bidders. We have confirmed that all required forms were submitted in accordance with the Contract Documents. We also verified that Mesquite Electric, LLC, is not listed on any federal excluded parties list.

For the required Contractor's Statement of Qualifications, Mesquite Electric submitted evidence of financial responsibility but did not submit evidence of competency. I contacted Mesquite Electric, and they provided the evidence of competency which included past experience on similar work, a list of equipment and personnel for the project. This failure to provide all the information for the Statement of Qualifications can be considered a minor informality or irregularity in the bid and can be waived by Hurricane City.

We have reviewed the contractor's qualifications and financial statements and consider this firm capable of completing the project. Mesquite Electric's bid of \$345,800.00 is approximately 9% higher than the Engineer's Estimate.

With only one bid submitted, we compared the Mesquite Electric's bid with recent airport AWOS projects. The Mesquite Electric bid is slightly higher but comparable to other similar projects. It is our opinion that the bid proposal submitted is fair and reasonable given the current bidding climate.

Based on the submitted information and our evaluation, we recommend Hurricane City award the project to Mesquite Electric in the amount of \$345,800.00, subject to FAA concurrence.

The attached AIP-014 Funding and Costs spreadsheet shows the AIP-014-2025 FAA grant will be \$325,000, in addition to the \$124,073 in Program Income from Hurricane City and the grant share from both UDOT and Hurricane City.

After FAA concurrence, we will provide you with the Notice of Award and Contract forms for execution by Hurricane City and Mesquite Electric.
